With reference to the above referred memo and subject, I would like to inform you that the above complaint has been enquired by the Technical Assistant of Ausgram-I Dev. Block and duly endorsed by the Block Development Officer & Block Programme officer, Ausgram-I Dev. Block.

It appears from the report that Sri Souvik Sikdar and some other job card holders did not work in the scheme namely re-excavation of Samudighi pond, but payment for wage was made to them & they withdrew the wage payment from the Bank account.

In this respect BDO & BPO Ausgram-I issued a letter to above mentioned job card holders for refund the amount to the Gram Panchayat Account vide his memo no.-119/NREGS/Aus-I dt.-13.07.2011.

Sri Souvik Sikdar, has in complying direction of BDO & BPO Ausgram-I (vide no. 119/NREGS/Aus-I dt.-13.07.2011) deposited an amount of Rs.486/- to the Berenda GP.

In this regard vide this office memo no. NREGS/III/16/908 dt.-22.07.2011 Block Development Officer & Block Programme officer, Ausgram-I Dev. Block was directed to lodge FIR against the concerned supervisors, who are directly involved in misappropriation of MGNREGS fund and fabrication of Muster Rolls in connection with the above noted work.

Accordingly, BPO & BDO Ausgram-I Dev. Block has also lodged F.I.R against the concerned supervisors to Ausgram Police Station for the same.(Vide his memo no.-130/NREGS/AUS-i dt.-25.07.2011)
