
Sub:- Complaint regarding irregularity & corruption in MGNREGS

Please refer to the complaint letter dated 01-08-2011(with 3 pages enclosure) of Shri Shailen Bhattacharyya, State Secretary, Communist party of India (Marxist-Leninist), Burdwan-Birbhum Regional Committee, Vill. + P.O.- Kendra, District.- Bardhaman, 713380, addressed to the District Magistrate, Burdwan on the above subject. A photo copy of the said complaint was endorsed by your good self to the Ombudsman, MGNREGS, Burdwan.

In this connection, you were requested to make it convenient to come to the office of the Ombudsman (MGNREGA), Burdwan on 08-09-2011 & subsequently on 13-10-11 to authenticate the complaint along with the supporting documents/ evidences in this regard. However, it is noticed that you failed to appear before the Ombudsman on each such occasion and also did not either give any intimation in this regard or requested for any re-fixing of the appointed dates or time.

The subject complaint was originally addressed to the D.M. Burdwan for necessary actions and it is understood that the same is being pursued by the District Authorities. As per established procedure, once a case has been referred to and taken up by an appropriate authority for investigation, further investigation should be left to them and a parallel investigation by other authorities should be avoided. Further action by the other authorities can be taken only on the completion of investigation by the former on the basis of their report.

In view of the position explained above, your representation to the Ombudsman (MGNREGA), Burdwan is liable to be dismissed for default. It is, however, made clear that the undersigned has not examined the merit or otherwise of the complaint in question. If on conclusion of the investigation/findings of the District authorities with regard to the original complaint you still feel aggrieved, you may file a complaint directly to the Ombudsman (MGNREGA), Burdwan with relevant documents following the procedure for necessary redressal.


